ANNUAL RICKA COOKOUT Lincoln Woods State Park

The club provides the hot dogs and hamburgers (including veggie burgers on request), rolls, buns and condiments. You bring the side dishes, beverages, and your boat! If you'd like, bring enough of your side dish to share, and please remember that alcoholic beverages are not allowed in Rhode Island's state parks. (What's in your water bottle is your business, as long as you don't draw undue attention.)

Picnic site 45 is right on the water so bring your boat if you can, and if you can't, at least bring your PFD and favorite paddle. Somebody will surely let you borrow their boat for a while. Capsizes happen, but don't plan on intentional swimming—it's prohibited outside the designated swimming area. The sites are reserved for the entire day so get there as early as you like. If you encounter fishermen or picnickers, just let them know we have a permit for the sites. Expect food to be served starting around 6:15.

RSVPs are required so we can be sure to have enough food. Call Kevin or Julie Allsworth at (860) 779-7478 no later than Saturday, July 14th.

Directions: Take the Lincoln Woods exit (Twin River Road) from Rt. 146 and follow the signs. Go past the booth at the park entrance (with the exception of beaches, RI no longer charges for entry to state parks) and turn right. About 100 yards down the road turn left at the sign to site 45. (Look for a BIG rock.) We've reserved site 46 also, so don't worry about blocking it when you park.

EPA Rates Narragansett Bay Condition "Poor"

In its 2007 National Estuary Program Coastal Condition Report on 28 major US estuaries, the EPA concludes that the overall condition of Narragansett Bay is "poor." Among the indicators cited are low dissolved oxygen levels, fish kills, eelgrass loss, macroalgae blooms, benthic community changes, and a shift in the bay's dominant fish community from bottom-dwelling to water-column-dwelling species. Arson likely in blazes that damage kayak shop, night club

WESTPORT 6/29/07— Early Friday morning fires burned a kayak shop and many of its boats and damaged part of the empty Alhambra's night club in Westport. Investigators are trying to determine what caused the fires that were reported within 15 minutes of one another shortly before dawn and whether they are connected. Both are considered "incendiary," said the fire department's Lt. Michael P. Silva At Osprey Sea Kayak Adventures at 489 Old Country Road, fire was reported at 3:56 a.m. and apparently started in a porta-john on the rear side of the building. It charred the entire back of the building, burned an entire rack full of rental kayaks and canoes, and melted many more kayaks on nearby racks. Altogether some 50 boats were destroyed.

Carl Ladd, who owns the shop with his wife, Sam, said some new kayaks inside were spared but that many life jackets, wetsuits and other gear inside sustained smoke and water damage. Shop employees were busy tossing those outside Thursday morning. He was asleep at home at around 4 a.m. when he learned of the fire, Mr. Ladd said.

"I got there as fast as I could and the firefighters already had it out. They did a good job to save the building."

West Nile/EEE Status Update

(June 29, 2007)PROVIDENCE - The Department of Environmental Management announced that test results from all 50 mosquito pools, or samples, from 26 traps set statewide during the week of June 18 are negative for both West Nile Virus and Eastern Equine Encephalitis. However, West Nile Virus and Eastern Equine Encephalitis are both firmly established throughout the state. Therefore, throughout the mosquito season, residents are encouraged to protect themselves by eliminating mosquito breeding grounds and avoiding mosquito bites. Personal protection is the first line of defense against mosquitoes that can carry diseases such as West Nile Virus and EEE and is by far the most effective way of avoiding infection.

The verdict on a cause was not in early Thursday but arson seemed a strong probability.

"The last I knew, porta-johns don't spontaneously combust," Mr. Ladd said.

Also arriving early was Elizabeth Mercer, who owns the building with her husband, Paul Izyk.

"We had just re-shingled not long ago," she said, a fact that may have prevented the building's total loss since new shingles burn more slowly than old, dry ones. "It's a real shame." It will take awhile to determine the extent of their loss, but Mr. Ladd said he imagines they will rebuild their business.

"We are already getting good support. A buddy has lent me a fleet (of rental kayaks) from another shop." He said that as soon as they are able, they hope to get their rental and lessons business going again.

"At least the river is still there," Ms. Ladd said.

Ms. Mercer said that quick work by the firefighters spared much of the building and she hopes to be able to rebuild. Mr. Ladd guessed that the building dates back a good couple hundred

years. It burned once before and was rebuilt, he said. The 1938 hurricane "pushed it across the street and they put it back on its foundation."

Over the years, a series of businesses have operated from this building by the head of the river. Ms. Mercer recalled Paper Moon, Country Cottage, "and I believe there have been variety stores and an ice cream shop."

Firefighters from Westport and Dartmouth contained that fire in 30 minutes.

A short while earlier Thursday, at 3:41 a.m., firefighters were called to the former Alhambra's nightclub at 803 American Legion Highway. The first firefighters to arrive reported heavy flames coming from a vacant apartment there.

Three engines and one ladder for Westport as well as a tanker from the Tiverton Fire Department mounted an aggressive attack and managed to stop the fire before it extended to the remaining sections of the structure. Members of the Westport Fire Dept. Investigation Unit, Westport Police, State Fire Marshal's Office and the Bureau of Alcohol, Tobacco and Firearms are investigating both blazes. Later in the morning, they were digging through the charred section of Alhambra's in search of clues.

Coast Guard Sinks Weaver's Cove Plan

A preliminary assessment by the U.S. Coast Guard denies Weaver's Cove Energy's navigation and safety plan, blocking the Liquified Natural Gas terminal proposed for Weaver's Cove in Fall River.

"This is an enormous victory for the Bay Community," declared Save The Bay Excecutive Director Curt Spalding. "Save The Bay strongly urged the Coast Guard to put the interests of the Bay first and it has done so. As we have said from the beginning, Weaver's Cove LNG is not right for the Bay, and we are extremely pleased that the Coast Guard's assessment reached the same conclusion."

Spalding also praised Rhode Island Sen. Jack Reed and the Congressional delegations of both Rhode Island and Massachusetts for their leadership in defeating this proposal.

The Coast Guard rejected the developer's plan to use smaller LNG tankers to pass under the Brightman Street Bridge.

Based on his review, Coast Guard Capt. Roy A. Nash wrote in a letter to Weaver's Cove Energy CEO Gordon Shearer, "the waterway may not be suitable for the type and frequency of LNG marine traffic contained in your smaller tanker proposal."

When paddling over waterfalls is no longer a thrill, it's time to add horsepower

Heading straight for a rock wall along New Zealand's Waimakariri River Gorge wouldn't normally faze Shaun Baker. But this was a new experience even for the world-record-holding waterfall jumper—this time his kayak had an engine in it, skipping him like a stone at more than 30 mph. Finally he backed off the throttle just enough to steer himself parallel to the wall and avert disaster, before gunning it back up to full speed.

A few years ago, Baker grew bored with performing crazy feats in standard kayaks, so he and a few friends decided to change the craft itself by adding some extra power. They picked the only engine that would fit in a six-foot-long freestyle kayak: a small, flat, 45-horsepower model developed by a company that makes motorized surfboards. Engineer Andy Selway cut a hole in the back of the kayak, built a frame, and rigged the engine to turn a Yamaha jet ski's pump and impeller, which draw in and expel water. Since the jet-ski parts were designed to handle 75 horses, he machined them down so they would better match the motor.

Once the kayak was complete, Baker worked to learn to control it, which ultimately saved his hide. After his close call in New Zealand, he went on to set a kayak world speed record of 35 mph. Now he's looking for new adrenaline-drenched challenges. Aerial backflips, anyone?

Tuesday night after the man who

The man apparently saw a story about the missing canoe in the Morning Sentinel and called police. "He was apologetic from the moment he called," police Officer Michael Sellar said. "He was forthcoming." The back of the for-sale sign Handy placed on the canoe had previously

been used to sell a television and the words "works mint \$50" were written on it. Handy had written "Free" in dark letters on top of the price after the television did not sell, he said. Handy said he had taped the for-sale sign on the canoe; the man who took it told police he saw only the "free" side, according to Sellar.

"It was a colossal misunderstanding," Sellar said.

Meanwhile, the man who returned the canoe has bought another one, according to Sellar, who said he is glad the case is resolved so that both parties are satisfied.

"We have so few happy endings around here," he said.

KAYAKING ROGER WILLIAMS PARK

Where can you paddle your kayak along four miles of coastline located in 6 interconnected lakes and see impressive early 20th century architecture with only a single launch?

The surprising answer is Roger Williams Park!

Roger Williams Park was built in the late 1800's by the renowned landscape architect Horace W. S. Cleveland in an area of over 430 acres of mostly marsh and bog lands. Cleveland's true genius was the utilization of the landscape that scooped out lake beds from the marsh areas and made gentle hills from the excavated material until the true beauty of this jewel was apparent.

There are two decent launch sites and anyone of them will allow you to follow the coastline and 4 miles later you will be right back where you started except you will have paddled in 6 different lakes. If you start your paddle from what I call Bonus Site 2, Polo Lake, this is what you will find.

Polo Lake connects with Williams Lake. Along the shore of Williams Lake you will find the Seal House and the famous Japanese Gardens. You can paddle into these distinct areas and see the platforms that the seals once frolicked on and the tiny islands with the arched footbridges that make up the interior of the Japanese Gardens. The flora in this area is world renowned for its diversity and beauty. A striking wrought iron bridge lies just beyond the view of the Carousel Village. Go under this bridge and enter Pleasure Lake. This is where the Queen Anne style Boathouse is located, an impressive structure that was built in 1896 and recently renovated in 2000. Commercial boat rides and paddle boat rentals originate from the large dock behind the boathouse.

Just after the boat dock you enter Cunliff Lake by going under a massive granite bridge named after the famous Indian Chief, and friend of Roger Williams, Miantunnomu. This beautiful bridge has unique tapered and curved turret elements built into the buttress supports as well as the name carved into the railing area that can only be seen from the water.

It is a fairly long paddle in Cunliff Lake but the view of the Temple to Music makes it all worth while. The sight of this massive white Vermont marble Greek style structure makes it hard to believe that you are in Providence. Paddle along a peninsula and you will enter the long narrow Elm Lake which will take you to the southern end of the park's waterways. At the very end of this lake is a waterfall made from stone steps whose overflowing water travels a short distance to go under an arched stone bridge that appears to have been made from all naturally rounded and worn stones.

Head north along the eastern shore of Elm Lake, and just before you enter Edgewood Lake you pass by two small islands that serve as habitats for a large variety of waterfowl. My all time favorite to see is the prehistoric looking Great Blue Heron. These birds, which can stand 4 feet tall, exhibit the most remarkable silent patience as they stalk their next meal. Edgewood Lake lies along the eastern border of the park and it is here that the carved landscape with its gentle hills and scooped out hollows is very apparent. The end of Edgewood Lake is marked by another granite bridge named after another Indian Chief, and friend of Roger Williams, Caunounicus.

Once under the bridge you are back in Pleasure Lake. If you follow the north shoreline you will see the monument to the Italian inventor of wireless radio, Marconi.

Along the shore and under the wrought iron bridge brings you back into Williams Lake and then under a granite bridge with the year 1889 carved into the railing and you are back where you started: Polo Lake.

This trip is a great opportunity for adventure and amazement for all ages and levels of skill. Enjoy!


